Model Release: Even though the client will receive a CD of the images, unless otherwise specified, it is understood that any and all rights to proofs, final or sample prints, thereof shall remain the property of the photographer and may be used for advertising, display, portfolio or any other purpose thought proper by the photographer. In addition, the client may reproduce prints from the CD at any time for his/her own personal use. Client may not profit in any way from the photographer's work.

___3. If the photographer cannot perform this agreement in whole or in part due to a fire or other casualty, acts of God or nature or terror, or other cause beyond the control of the parties or due to Photographer's illness or injury, then the photographer will return all fees to the Client(s) (minus any costs already used i.e. plane tickets) but shall have no further liability with respect to this Agreement. This limitation on liability shall also apply in the event that photographic materials are damaged in processing, lost through camera malfunction, lost in the mail, or otherwise lost or damaged without fault on the part of the photographer. Client(s) agree that an entire wedding cannot be replicated, reenacted or repeated for the purpose of a re shoot and limits the photographer's liability to the amount paid under this contract.

___4. \$100.00 is due as a deposit upon signing of this contract. The remainder of the payment is due day of wedding. Any fees are non-refundable in case of cancellation or date change by client.
